All YMCA Day Camp employees are required to participate in a 3-4 full days of training process that serves as the foundation for ensuring that our employees can successfully carry out their jobs, and that the staff team is prepared for the summer. This training is required for all new and returning YMCA Day Camp employees. Time off during staff training will only be approved to write exams. This must be arranged ahead of time, as the staff member will be required to complete make-up training prior to the start of camp.
